- 5. The mess amount is excluded from the given room charges.
- 6. Single occupancy of a 2 or 3-seated room will be considered fully occupied, and the occupant must pay the full room rent.
- 7. If a student is vacating the hostel, s/he must give an application 15 days prior.
- 8. The hostel is for a 10-month duration, and leave will not be adjusted in the hostel fee.
- 9. From the 2nd year onward, hostel room charges must be submitted by 1st August.
- 10. Rooms will be reallocated in the new sessions.
- 11. Any damages to the hostel property will be charged to the students.
- 12. Hostel residents are expected to sign in and out of the hostel when entering or leaving. It is important for the safety and security of the hostlers.
- 13. Hostel residents are expected to attend the institute during institute hours and are not allowed to stay in the hostels except in case of illness.
- 14. Hostlers are expected to keep their rooms clean and tidy and maintain the decorum of the hostel.
- 15. Hostels prohibit the consumption of alcohol, drugs, and smoking on the premises.
- 16. The use of electrical appliances, such as heaters or electric kettles, is restricted due to safety reasons.
- 17. Hostel residents are responsible for their personal property and must take appropriate measures to secure their belongings. They are advised not to have any valuable/expensive things in the hostel rooms.
- 18. Hostel authorities will not be responsible for any theft or damage to their belongings.
