## REGARDING AADHAAR AUTHENTICATION OF EACH ELIGIBLE BENEFICIARY ON THE DIGISHAKTI PORTAL BEFORE THE DISTRIBUTION OF TABLETS/ SMARTPHONES UNDER SWAMI VIVEKANANDA YUVA SASHTIKARAN YOJANA

This is to inform all students that to prevent duplication in the distribution of tablets/smartphones to eligible beneficiaries, the Government has mandated Aadhaar authentication. A facility for this has been provided on the DigiShakti portal.

A link for Aadhaar authentication of eligible beneficiaries is available on the homepage of the DigiShakti website.

Therefore, all eligible beneficiaries must complete their Aadhaar authentication process before receiving tablets/smartphones by following the procedure below:

- **1. Visit the DigiShakti Portal**: Eligible beneficiaries should click on the "e-KYC through Meri Pahchan Portal" link available on the DigiShakti website (<a href="https://digishakti.up.gov.in">https://digishakti.up.gov.in</a>).
- 2. Search for Student Details: On the "Search Student Details" page, beneficiaries must search for their name by entering details such as their university, institution, and enrollment number. If the beneficiary's details are found, they will be directed to complete Aadhaar authentication through the e-Pramaan Meri Pahchan Portal.
- 3. Complete Aadhaar Authentication:
  - The beneficiary must register on the e-Pramaan Meri Pahchan Portal and complete the e-KYC process.
  - An OTP will be sent to the beneficiary's registered mobile number or email ID to authenticate Aadhaar.
- **4. Verification of Details**: If the beneficiary's Name, Gender, and Date of Birth on the DigiShakti portal match their Aadhaar details, the "Aadhaar e-KYC Status-Verified" message will be displayed on the "Search Student Details" page.
- **5. Failed Authentication**: If the details do not match, an "Aadhaar e-KYC Status-Failed" message will be displayed.

In the event of a failed authentication, beneficiaries must correct their details either on the DigiShakti portal or on their Aadhaar card. Once corrections are made, they can restart the Aadhaar authentication process.
